The Company is pleased to inform that pursuant to the provisions of Section 108 of the Companies Act, 2013, read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as substituted by the Companies (Management and Administration) Amendment Rules, 2015 and pursuant to Listing Agreement, the members are provided with the facility to cast their vote electronically through the remote e-voting services provided by National Securities Depository Limited (NSDL) on all the resolutions set forth in the Notice. The remote e-voting period commences on Tuesday, the 22nd September, 2015, at 9:00 A.M and ends on Thursday, the 24th September, 2015 at 5:00 P.M. The remote e-voting module shall not be allowed beyond 5:00 P.M on Thursday, 24th September, 2015. The remote e-voting module shall be disabled by NSDL for voting thereafter.

Once the vote on a resolution is cast by the shareholder, the shareholder shall not be allowed to change it subsequently.
